RECITALS

WHEREAS, the Departments are linked by common academic, cultural and regional interests;

WHEREAS, the Departments wish to enable cooperation and exchange in all academic areas of mutual interest for the benefit of the respective Departments and to promote the development of joint studies, activities and other educational programmes of mutual interest;

WHEREAS, this MOU supports the English Department, Bikali College mission and English Department, B P Chaliha College, Nagarbera, Kamrup, Assam mission.

THEREFORE, in consideration of the relationship to be established and the covenants set forth herein, the Departments agree as follows.

ARTICLE 1

Area and Scope of MOU

- **1.01 Area of Cooperation**: Areas of collaboration may be proposed by either department and may include, but are not limited to:
 - · Joint teaching, research or cultural activity
 - Mobility of faculty and students between departments
 - Staff professional development
 - Sharing or creation of educational materials and resources
 - Joint and articulated courses (add on courses)
- 1.02 Scope of Cooperation: Any specific activity developed under this MOU shall be detailed in subsequent agreement, signed by each Department's authorized signatory, which will describe the scope of the proposed activity, intended outcomes, budget and responsible departments or individuals.
- **1.03** All activities shall be subjected to the availability of funds and the approval of each department's authorized representatives.

ARTICLE 2

Procedures

2.01 Liasons: In order to carry out and fulfill the aim of this MOU, each department will appoint appropriate persons at each of their campuses to coordinate the development of collaborative activities. Through these contact persons, any of the Departments may initiate proposals for activities under this MOU. The contact persons will additionally be responsible for the evaluation of activities under this MOU according to the practices of their respective Departments. Any notice to the Departments under the MOU must be in writing and shall be deemed given when received by the Department's designated contact person.

ARTICLE 3

Term and Termination

3.01 Term: This MOU shall take effect upon signature by the Department ("Effective Date") and, unless earlier terminated, will continue for a period of 5 (five) years from the Effective Date.

3.02 Extension: This MOU may be extended by mutual agreement of the Departments, which must be reduced to writing and signed by the Departments.

3.03 Termination: This MOU may be terminated at any time by any Departments upon written notice to the other Departments. Any supplemental agreement entered into pursuant to this MOU will not automatically terminate with the termination of this MOU, and any student then enrolled in a programme created by such supplemental agreement shall be permitted to complete that programme under the terms and agreements of that supplemental agreement.

3.04 Amendment: This MOU may be amended at any time by any of the Departments upon mutual consent, which must be reduced to writing and signed by the Departments.

ARTICLE 4

Miscellaneous

4.01 Resolution of Disputes: This MOU is based on the common trust and good faith of the Departments. In case of disputes, the parties, through the liaisons designated in Section 2.01 of this MOU, shall make good effort to obtain an amicable resolution.
